Dear Town of Orangetown Resident,

The Town of Orangetown is pleased to announce the launch of Rockland Community Power, a Community Choice Aggregation (CCA) program¹ that allows us to pool local electricity demand with other Rockland County municipalities to provide low cost, **fixed-rate electricity supply**. Each participating community has selected Joule Community Power² as Program Administrator. Joule works on behalf of the municipalities to secure energy supply at the most favorable terms and ensures there are **no contract or exit fees** for consumers.

Supply Options

There are two fixed-rate electricity supply options under our program: **(1) Standard** and **(2) 100% Renewable**. You may choose between these supply options or opt out of the program. The Town of Orangetown has chosen the Standard Option as the default. **You will automatically be enrolled in the Standard Option unless you choose the 100% Renewable Option or opt-out of the program.**

- **Standard Option:** Your electricity supply is a mixture of fossil fuels, nuclear, and some renewable energy.
- **100% Renewable Option:** 100% of your electricity supply is matched by Renewable Energy Certificates (RECs) provided by New York State renewable power plants (hydropower, wind, solar). To switch to the 100% Renewable Option, please call (845) 859-9099 or visit rocklandcommunitypower.com and submit your information through the Enrollment/Change form under "CCA" in the navigation bar.

Rockland Community Power Rates

Rockland Community Power has secured rates for electricity, through a competitive bidding process, that will remain stable for two years.

- Constellation NewEnergy, Inc. will be your new supplier, beginning on your first meter-read after November 1, 2020.
- The new rate will remain fixed for a 24-month period through October 2022.

Orange & Rockland will continue to be responsible for the power lines that deliver your electricity and will continue to bill you. Please contact Orange & Rockland in the event of any service interruption.

Enrollment

If you wish to opt out of the program, please let us know by October 28. If we do not hear from you, you will be enrolled automatically in the Standard Option, and your account information (including energy usage) will be shared with Constellation NewEnergy. However, you may leave the program at any time without any fee or penalty. If you choose to remain in the program, your new rate will take effect in November 2020.
