The Village of Upper Nyack is pleased to announce our participation in the program renewal of Rockland Community Power a Community Choice Aggregation (CCA) program administered by Joule Community Power, a division of Joule Assets, Inc., that puts control of energy supply choices into local hands.

Through a competitive procurement process Constellation NewEnergy, Inc. has been selected to replace Orange and Rockland as the default supplier of electricity for residential and small-commercial accounts within our community. We have chosen 100% renewable supply as the default product offering for our community but you have the choice to opt-down to a standard supply option by contacting Rockland Community Power at (845) 859-9099 x1 or [info@rocklandcommunitypower.com](mailto:info@rocklandcommunitypower.com).

All eligible residential and small-commercial electricity customers will be automatically enrolled in the renewable supply product beginning with the bill cycle following April 1, 2023 and will be able to continue to receive the CCA program price of \$0.12937/kWh for electricity through September 30, 2024. You may cancel at any time with no fee or penalty.

Below is a comparison of Orange and Rockland electricity supply pricing with the CCA program pricing. While this is not indicative of pricing going forward, it does provide a basis for comparison of standard supply offerings. If you choose the renewable product offering, you will pay a premium for this product over the utility standard product pricing, however, you will be contributing to NYS clean energy goals.
